Reference is invited to your online proposal no. IA/AP/MIN/238160/2021 dated 03/02/2022 seeking Change of company name in the Environment Clearance cited above from M/s. Prism Cement Limited to M/s. Prism Johnson Limited.

2. The Ministry of Environment, Forest and Climate Change (MoEF&CC) has examined the request submitted by you and the following points are noted:
 - i. Project proponent originally obtained Environment Clearance from MoEF&CC vide letter no. J-11011/37/98-IA.II(I) on 8/8/2002 for setting up of 2 MTPA cement plant at village Kotapadu, Tehsil Kolimigundla, Kurnool District, Andhra Pradesh under the provisions of EIA notification, 1994. However, the project has not been implemented reportedly.
 - ii. EC for the expansion project cited above was accorded by the Ministry vide letter no. J-11011/166/2008-IA.II(I) dated 27/03/2009 in the name of M/s. Prism Cement Limited under the provisions of the EIA Notification, 2006 for Integrated Cement Plant involving expansion of Cement Plant (2 MTPA to 4.8 MTPA), Clinker (3 MTPA), Limestone Mine (663.46 ha, 4.4 MTPA) and Thermal Power Plant (48 MW).

6. This issues with the approval of the Competent Authority.


